Sub: Regarding suggestions for development related issues and some pending grievances of executives in Rajasthan circle.

**Respected Sir,**

I want to congratulate you for achieving the revenue collection target of Mar-21 assigned to Rajasthan circle. This was possible only due to your personal efforts and continuous monitoring. We are assured that Rajasthan circle will touch new milestone in future under your dynamic leadership.

I want to submit some operation and HR related issues for your kind notice and favorable order please.

### **1. Provision of FTTH connection/enrolment of new TIPs:**

As you are well aware about the present Covid-19 pandemic spread in whole India which force the Government to lockdown. We may convert this pandemic situation into an opportunity as the demand of work from home and online classes is increasing again. We may explore this demand by reaching to maximum premises and providing FTTH connection on war footing basis. We may also start booking of FTTH connection online at BSNL website. SMS with link may be thrust to subscribers for information and booking of FTTH. These leads may directly be sent to TIP vendors PIN code wise. The TIP vendors should be monitored properly so that they cannot demand undue amount of ONT and fiber cable for new FTTH connection. In this regard targets may be assigned to TIP vendors. This will improve our image in the public as well as improve our achievement of FTTH targets and reduce the burden at the end of financial year.

### **2. Request to immediate withdrawal of order of organizing SIM Mela:**

At present the spread of COVID-19 in the 2<sup>nd</sup> Wave is almost in the community transmission stage. It is more severe than last year. The situation of lockdown has arises in many cities. Due to lockdown/early closing of market, hot summer season and severity of Corona, it is not possible to organise SIM Mela for our sales team. You are requested to immediately withdraw the order of organization of SIM Mela till the situation becomes normal. Instead of this we may focus for bulk connection through our EB team during this period.

### **3. Own cost request transfers of JTO, SDE and AGM cadre:**

I want to convey my sincere thanks for issuing transfer orders of executives in a rationalize manner between working at tenure station and on longest stay basis as per demand of our association. I am assured that own cost transfer request of rest executives who have completed three or more years of service upto 31.03.2021 at their posting stations will be considered by your office soon.

**4. Request of Sh. Deshraj Gujar JTO Ajmer for change of posting station from Sirohi-TD to Bhilwara-TD:**

As per CGMT office letter no. STA/8-15/JTO/RR/2018/Part-33 dated 21/12/2018, the own cost transfer request of Sh. Deshraj Gujar from Ajmer-TD to Jaipur-TD was registered in request register on 13/03/2018 at Sr. No. 22. But his name was removed from request register as per CGMT office letter STA/8-5/GB/Exe/Genl/2017-18/14 Dated 03/03/2020 without any reason.

Again as per request of our association vide letter dated 13/03/2020 his request for transfer was modified from Jaipur-TD to Bhilwara-TD which is registered at Sr. No. 84 as per CGMT office letter No. STA/8-5/GB/Exe/Genl/2017-18/20 dated 06/06/2020. Now he has been transferred to Sirohi-TD vide CGMT office letter no. STA/8-15/Ch.17/RTFR/JTO/2020/4 Dated 10/06/2020. Further, His wife is working as teacher in Kekri Ajmer. Previously his femur is also fractured while working on duty and rod is implanted for support.

Considering his family and health issues you are requested to revise his posting order from Sirohi-TD to Bhilwara-TD as per his request.

**5. Request transfer of Sh. Ajay Kumar AGM Banswara:**

Sh. Ajay Kumar is working at Banswara SSA soft tenure station since last fourteen years. Now due to his health issues he has requested for his own cost transfer from Banswara-TD to Jaipur-TD which is registered in request register. You are requested to issue transfer order of Sh Ajay Kumar as per his request.

**6. Request for Mutual transfer of Sh. Man Mohan Saini JTO Kota-TD and Hukam Chand JTO Jhalawar-TD:**

Sh. Manmohan Saini JTO (LC) Kota-TD and Sh, Hukam Chand JTO (Trans-I) Jhalawar-TD has applied through proper channel for mutual transfer. Their applications were recommended and sent from Kota to Circle office vide letter No. E-14/JTO/TFR/2019-20/299 dated 06.11.2020. Sh. Ganpat Patel HR No. 200700103 is working as SDE in Jodhpur SSA. Recently he is transferred from Jodhpur TD to Barmer TD vide your office letter dated 15/04/2021. Sh. So you are requested to provide him immunity from transfer as per BSNL(REA) Rules 2014 and arrange to cancel his transfer order from Jodhpur to Barmer.
